- Contractor/builder is Jean Ann Hodges of Hodges Custom Homes who has previously done at least two other remodels/additions in Amesbury

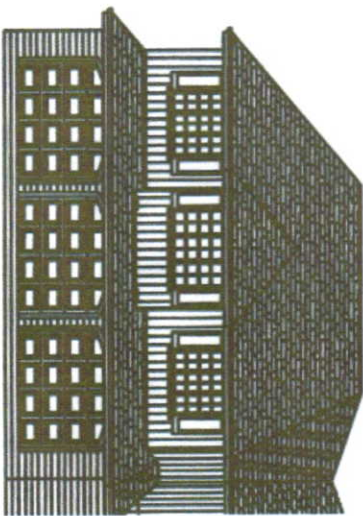

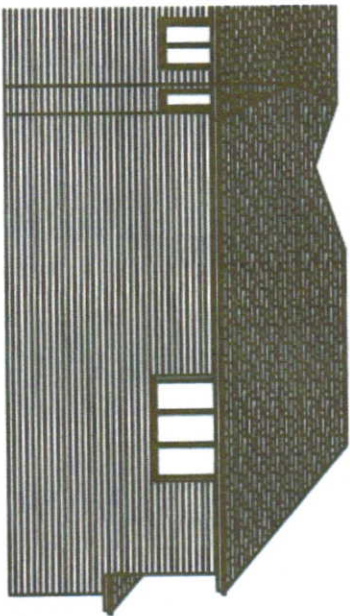

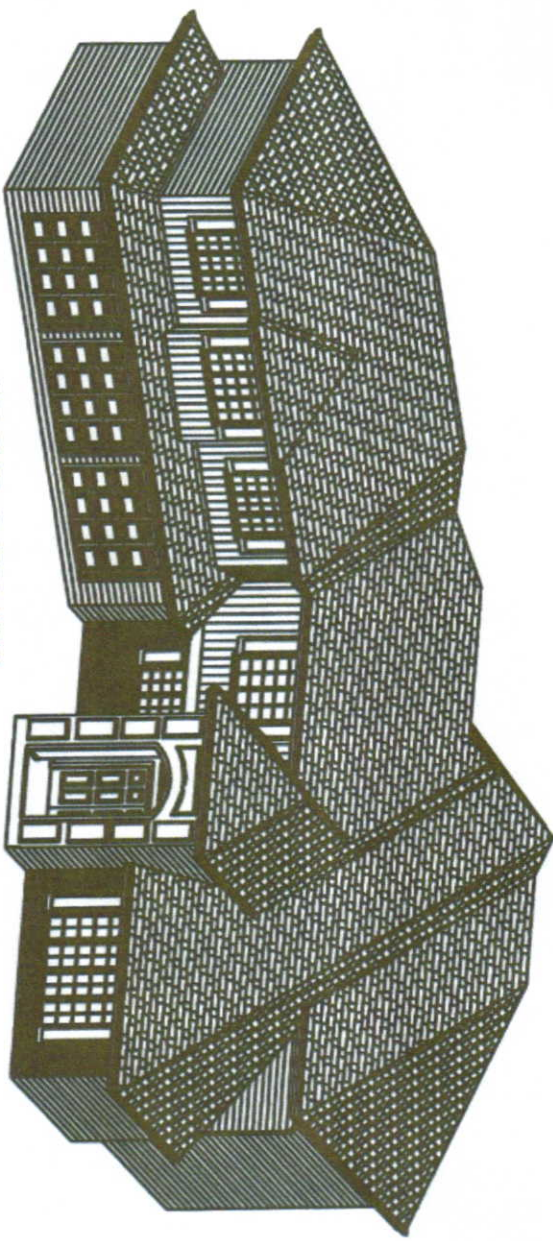
FRONT ELEVATION
